V) Tender document will be issued to interested tenderers free of cost on request by an application to the issuing authority in the Office of The Agent, Amritnagar Colliery, Survey Dept. On all working days. No tender document will be issued or received by POST.

VI) Tenderers are requested to deposit the requisite amount of Earnest Money as indicated against the work in the form of **Bank Draft** drawn in favour of '**Eastern Coalfields Limited, Area-IV**' on any Nationalized Indian Bank payable at **Raniganj preferably on SBI**.

VII) No tender shall be considered unless accompanied by the said Earnest Money.

VIII) Bid shall be submitted in the following manner:-

Single Envelope shall contain the following:-

1. GST Registration.
2. Particular Registration/clearance from the appropriate provident fund authorities, if applicable.
3. PAN Card (Permanent Income Tax Account Number)
4. Price bid part.
5. The bidders would give a declaration that they have not been banned or delisted by any Govt. or Quasi Govt. agencies or PSU's. If a bidder has been banned or delisted by any Govt. or Quasi Govt. agencies or PSU's this fact must be clearly stated and it may not necessarily be a cause for disqualification. If the declaration is not given, the bid will be rejected as non-responsive.

The envelope shall indicate the same of the work, name of the bidder along with the address, reference Tender Notice No. The tender will be accepted only if Earnest Money is deposited and other document found valid. By central/state Govt. as well as medical facilities on the colliery dispensary on payment. Payment of wages to the contract workers are to be made only through bank by the contractor. The contractor should get the account opened by the workers engaged by him/them. The contractor should prepare wages sheet for his/their employees in triplicate, copy of which shall be regularly submitted to the Personnel Dept. And copy to this office.

The responsibility of the contractor in respect of all payment to his/their employee will be complete & absolute. The company (ECL) shall have no liability whatsoever in this regard and shall be fully indemnified by the contractor against of any non-payment, Short-payment/Dispute/Award.

**IX) Submission of certificate from appropriate registered Chartered Accountant is requested by the tenderer if GST registration is not applicable.**

**X) ELIGIBILITY**

A. The intending tenderer must have in its name as a prime contractor  
Experience of having successful completed similar nature of work during the last 07 (Seven) years ending last day of Month previous to the one in which bid application are invited which should be either of the following .

- i. 3 similar complete works each costing not less than the amount equal to 40% of the estimated cost or
- ii. 2 similar complete works each costing not less than the amount equal to 50% of the estimated cost or
- iii. 1 similar complete work not less than the amount equal to 80% of the estimated cost.

**XI)** The validity period of the tenders shall be 120 days from the date of opening of price bid or received price bid, if any, other details may be obtained from detail tender notice/tender document. The bidder should furnish completed Bank A/C. No, Name of Bank & Name of Branch with postal address of the Bank.

**XII)** You shall have to ensure implementation of CMPF and miscellaneous proceeding Act-1948 and allied scheme framed there under in respect of your employees deployed by you and will have to recover statutory due and deposit the same along with-your contribution to the respective CMPF office and submit statutory returns under intimation to the principal employer. However if you are a member of CMPF scheme and your employee is cover under the scheme. you may continue to operate under CMPF scheme. The particulars of the scheme should be submitted to the office i.e. principal employer of the work.

**XIII)** The contractor will have to upload in details in respect of contractors labour employed by him in contractor labour payment. Management portal of CIL for contract issued for the said within 15days of starting of work and will update the same as and when required as per format provided in general terms and condition.

**XIV)** The attendance of contractor's employee shall be through Biometric attendance system. The device will be installed by the contractor and attendance recorded will be transferred to clip portal of CIL.


**XV)** The successful bidder shall have to deposit the performance security deposit within 21 days from the date of the issue of LOA/Work order may be given by authority, how is competent to sign the agreement in case of Non-submission of PSD by the contractor within 21 days from the date of issue of the LOA/Work order, a penal interest @12% p.a. of PSD value shall be charged from the contractor from 22<sup>nd</sup> day after issue of LOA/Work order. And up to 60 days subject to the minimum penal interest @0.5% of PSD amount, shall be taken from successful bidder. The amount of such penal interest shall be deducted from the 1<sup>st</sup> R/A bill of the bidder, and the same will be non-refundable.

If the contractor fails to submit the requisite deposit even up to 60 days, the contract is liable to be terminated with forfeiture of EMD and the company ECL shall ban such defaulting contractors from participating in future tenders in ECL for a minimum of 12 months period. Also, the failed contractor will be debarred from participating in re-tendering for the work.

**XVI)** No conditional tender will be accepted. All Government taxes, Payment of minimum labour wages etc. Which are in vogue in ECL will be applicable.

**XVII)** The intending tenderer are informed to go through the BOQ, term & conditions etc and inspect the site before quoting of the rate.

**XVIII)** Mere issuance of tender documents will not make the tenderers eligible for consideration of opening of their price bid. ECL reserves its right to reject or accept all/any tender without assigning any reason, thereof.
