A. SCOPE OF SCIENTIFIC STUDY:

To conduct and provide scientific study report on the following area:

- To conduct pressure, Quantity & hygrometric survey of existing & suggested ventilation circuit and ventilation planning.
- Study MMV characteristics, Mine characteristics and efficiency and suggest an alteration/modification, if required .Identify key leakage and optimal ventilation path to maintain sufficient ventilation in all district of R-VIII(T2), R-VII(B1), R-VII, R-VIIA , old working and minimize the risk of spontaneous heating in all said seam.
- Pressure balancing of isolation/sectionalisation stopping, if required in working seams and suggest alternation of ventilation route for development or depillaring by caving districts with CM in R-VIIIA Seam, to eliminate the risk of fire from overlying seam also.
- Change in the pressure characteristic after drivage of new incline in RVIII-B1, RVIII-T2 and RVII and RVII-A seam.
- Ventilation rearrangement for the induction of two nos of low height continuous miner in RVIIA seam.
