The Cover-envelope shall indicate the Name of the Work, Name of the bidder along with the address, reference Quotation Notice No. The second envelope shall be opened only if the documents in first envelope are properly submitted.

The Quotation will be opened on 04 -09--2024 at 3-30 P.M in the office of the undersigned in presence of the intending Quotationers or their authorized representative who may wish to be present.

The validity of the bid shall be 120 days from the last date of submission of bid.
