<b>3.</b>	<b>ELIGIBILITY CRITERIA</b>
<b>A</b>	Experience of having successfully completed (not less than 75% of the contract values) similar type of works in underground / Surface during last 7 years ending last day of the previous month to the one in which Bid Application are invited should be either of the following: - i) Three similar completed works each costing not less than 40% of the tender amount or, ii) Two similar completed works each costing less than 50% of the tender amount or, iii) One similar completed work costing not less than 80% of the tender amount.
<b>B</b>	i) Photo copy of PAN, GST, and Last G.S.T return submitted, EPF/CMPF Registration, Valid Trade License. ii) Bank Account No. with Name of the Bank, Name of the Branch, & IFSC No. iii) Status details of the firm in case of Partnership / Limited Company, (Copy of partnership deed/memorandum of association and article of association in case of limited company). iv) Form-16A/IT Return or, Financial Statement duly certified by AFM of Kajora Area or, any other Area of the ECL/H.Q. or, any PSU or, Govt. Establishment for last 03 (three) years or, Average annual financial turn over during last 03 (three) years.
<b>C</b>	Self-Declaration should be given by the Tenderers for the following. i) That the firm has not been banned/delisted/black listed any time by the State Govt. /Central Govt. or, PSUs. ii) That they or their partners do not have any relatives working in ECL. iii) That the entire document submitted along with this tender is genuine, authentic, true and valid. iv) That in case of any information or document is found to be false/incorrect, department may cancel his tender and action has deemed fit may be taken against him.
<b>D</b>	i) The Quotation papers including BOQ will be issued free of cost to the interested contractors during date of publication on written application at concern department. ii) Sealed Quotation shall be submitted as on date of submission in two part as detailed below: - a) <b>First Envelope</b> shall contain all required documents for eligibility b) <b>Second Envelope</b> shall contain bid document duly signed and BOQ duly filled in. Rate for this quotation should be quoted on item wise. These two envelopes shall be placed in another envelop and submitted by the bidder. The cover envelop shall indicate the Name of Work, Name of Bidder along with the address, Reference Quotation Notice No. The second envelop shall be opened only if the documents in first envelope are properly submitted and establish the eligibility of contractor.
<b>4.</b>	<b>Validity Period of Offer:</b> The rates offered in Part II should be valid for 120 days from the date of opening of Part I of the Tender.
<b>5.</b>	The contractor/ contractors shall make necessary payments of the wages as per high power committee through bank as well as provision of payment of provident fund for the workmen's employed by him for the work as per laws prevailing under provision of CMPF and deposit the same along with employer's contribution (contractor's share) to the respective CMPF / EPF Office and to submit statutory return under intimation to principle employee.
<b>7.</b>	The Contractor / contractors shall provide HELMET, FOOTWEAR, SAFETY BELT and other protective and safety equipment to the workmen at their own cost.
<b>8.</b>	The Contractor / contractors should have make payment of Rs. 15.00 lakhs as Ex-Gratia amount to the next of kin of any employee including contractors' workers dying out of Fatal mine accident as certified by DGMS, to the eligible dependent of deceased contractor's worker's engaged during work.
<b>9.</b>	ECL would not be liable for any compensation due to stopping/change in scope of work due to local disturbance, change in Govt. Policy, Law and any other judiciary obstruction of delay by any outside elements/ Agency.
<b>10.</b>	The Tenderers should visit the site of work before offering their tenders. Other details are available in the tender documents. No tender document will be issued or received by Post. After publication of tender the estimated quantity may be viewed from the concerned department.
<b>11.</b>	No conditional tender will be accepted.
