Dear Sir,

You were awarded the work of "Hiring of HEMM for removal and transportation of 402.30 L. Cum of OB and extraction & transportation of 92 L Te Coal from Hansdiha IV OC Patch in Sector-I of Sonepur Bazari Area." vide LOA no. ECL/HQ/CMC/LOA/Hansdiha Ph-IV SBA/638 Dated 26.09.2018 and Work order no. ECL/HQ/CMC/WO/ Hansdiha Ph-IV SBA/73 Dated 14.02.2019 for a period of 5 years.



The work has been terminated vide letter GM/SBA/2023/27 dated. 18.04.2023 and in continuation to above letter it is informed that the Empowered Committee of Functional Directors of Eastern Coalfields Limited in its Meeting (9th of 2023) held on 07.04.2023 (10:30 AM) approved the following:

• Termination of contract w.e.f. 03.02.2023 (i.e. date of final measurement of CMPDIL) awarded to M/s MIPPL-VSAIPPL-CRNMA(JV) for the work of "Hiring of HEMM for removal and transportation of 402.30 L. Cum of OB and extraction & transportation of 92 L Te. coal from Hansdiha IV OC Patch in Sector-I of Sonepur Bazari Area" as per clause No. 9 (b) of GTC along with recovery of loss / damage suffered by the Company, but not limiting to the proposed amount, of Rs. 12,514.92 lakhs (i.e. 20% of value of incomplete work) as per clause No. 9.2 (c) of GTC of agreement.

Final Revised Estimate (RE) on the terminated work shall be processed separately by the Area following all due process and procedure of agreement and considering all provisions of penalty and LD and recovery of loss/damage as per clause 6 of GTC in addition to recovery of loss/ damage as per clause 9 of GTC.

• Banning of Business of the contractor M/s MIPPL-VSAIPPL-CRNMA (JV) and its constituent partners of JV for a period of 3 (three) years as per clause No. 2 v (b) of Guideline for banning of Business of CMM Chapter 6.
