You were awarded the contract/work of "Hiring HEMM for removal & transportation of 144.68 L.cum of OB(including 10.00 L.cum of Re-handling of OB), extraction & transportation of 37.95 L.Te of coal and 146.10 L.cum of back filling of OB at Kapasara OC patch under Mugma Area(7 years production + 3 years backfilling)" as per work order no. ECL/HQ/CMC/WO/Kapasara OC Patch/600 Dated: 15.09.2018..

ECL Management has accorded approval on following action(s) against you with reference to above:

- a) Termination of the instant contract w.e.f. 30-06-2023 under clause No. 9 (a) & 9 (b) of Section II of GTC of the Contract Agreement.
- b) To recover loss/damage suffered from the contractor and impose penalty as per terms and conditions of the NIT by the Engineer In-charge.

Hence as per directives of competent authority following may be noted as "ORDER" with respect to the said contract:

- 1. Termination of the contract for the subject work awarded to M/S STA-BGM & M-SRSC(JV) w.e.f. 30-06-2023 as per clause no. 9 of GTC.
- 2. Banning of the business for the period of 12 months to all JV partners i.e i) M/s Sharma Transport Agency ii) M/s Biswajit Ghosh Mining & Movers iii) M/s Shree Rani Sati Carriers as per clause no. 9.2(c) of GTC of Contract Agreement.
- 3. Recovery of penalty including but not limiting to as per clause No. 9.2(c) of GTC for the approved value of Rs 29,61,32,571.42 Which will be recovered by forfeiting PSD and additional PSD submitted as BG amounting 5,51,52,271.00(Rupees Five crore fifty-one lakhs fifty two thousand two-hundred sevent-one and apisa zero only) in first instance and balace amount will be recovered as per clause 9.2(c) (ii) of GTC of agreement quoted below: Details of BG is given below in the tabulated form:
