Dear Sir,

You were awarded the work of 'Monthly Basis Cab and Taxi Hiring Service - Without Fuel' for period of 03 (Three) years vide GeM Contract No. GEMC - 511687732067096 dated 15.03.2024.

As per Contract you were required to start the work from 29.03.2024 but you requested to extend the commencement period stating that you are under medical treatment of P.U.S. and could not provide vehicle before 15.05.2024. L.O.A. was issued vide GM/ SBA/ Pers. /LOA/ 2024/697 dated 27.03.2024 considering your request you were allowed to provide vehicle latest by 21.04.2024.

Again, you submitted an application on 19.04.2024 requesting for another extension for commencement of your work but it was not feasible for the competent authority to grant you any further extension. You didn't deploy the vehicle within stipulated period even during extended period.
