Dear Sir,

You were awarded the work of "Contractual loading and transportation of 20 L Te coal from Depot/Railway Siding/Dump to TRS Hopper of New CHP/Silo for the period of 02 years" vide Gem Contract no. GEMC-511687789585476 dated 11.06.2024.

You have not submitted the Performance Security Deposit even though the contract explicitly mentioned that you had to do so within 21 days of issuance of GeM Contract. Also, the site was handed over to you on 12.06.2024 but you did not start the operations. Accordingly you were issued a show-cause notice and a notice of personal hearing scheduled on 12.07.2024 vide GM/SBA/24/65 dated 09.07.2024. You were asked to state the reasons why action shall not be taken against you as per Clause 4.3 of Terms & Conditions of the Contract and Clause 4.ii) of Guidelines On Debarment Of Firms From Bidding. You had, in response to the above notice, submitted a representation vide D/6/24 dated 12.07.2024.

2. Debarment of M/s Raj and Parmanand Private Limited and Directors of the firm namely, Shri Raj Kumar Nishad & Shri Parmanand Kumar for a period of 01 (one) year from the date of issuance of this order, from participating in future tenders of Eastern Coalfields Limited (ECL) as per Clause 4.3 of General Terms & Conditions of Contracts and Clause 4(ii) of Guidelines on Debarment of Firms from Bidding.
