- ii) Recovery of Damages not limiting to Rs. 1,57,35,624.71 (Rupees One Crore Fifty-Seven Lakh Thirty-Five Thousand Six Hundred Twenty-four rupee and Paisa seventy-one) is assessed as per Clause no. 9.2 (c) which is 20% of the values of incomplete work by forfeiting of Performance Security Deposit submitted as Fixed Deposit of Rs. 12,00,000.00 (Rupees Twelve Lakh only) in first instance and balance amount will be recovered as per Clause 9.2 (c) (ii) of GTC.
- iii) Debarring "M/s Paradise Transporters Pvt. Ltd" registered address, "Deepraj Apartment, Flat No. B2, Shastri Nagareast, Dhanbad-826001, Jharkhand, as well as its constituents Director's namely Shri COL DARYA SINGH, S/o SH. RAMJI LAL, 435, Defence Colony, HISAR, Shri SUBEDAR RAMJI LAL, S/o SH. DHANA RAM, Vill. Basra, P.O. Sarsana, Distt. HISAR and Shri DARYA SINGH, S/o SH. MARU RAM, V. & P.O. Runhat, Distt Bhiwani, for a period of 1 (one) year from participating in future tenders of ECL under clause no. 6.1 & 9.2 (c) of GTC. This will be with effect from the date of issuance of this letter i.e. 21.08.2023 for a period of 1 (one) year (Blocking period i.e. 1 month 24 days + remaining period i.e. **10 months 6 days effective from 05.10.2024**).
